

PROMOTION: WHAT'S IN IT FOR ME?

Most of us in the wood products business have known for many years that solid wood utilization and consumption in many sectors of the industry has substantially decreased. In particular decline is "grade" lumber or any solid lumber that is used in home or commercial building construction such as flooring, doors, molding, millwork, furniture, and so on. Two decades ago, the consumption of solid hardwoods used to make these products to satisfy demand was just north of 13 billion board feet, today it is just south of 6 billion board feet. The market for solid "grade" hardwoods has declined over 50 percent presenting a very concerning future for that sector of our industry. So, why should this story matter to those fortunate enough to be in our industry but out of the grade business? I think that is a fair and appropriate question.

The forest products industry in Missouri is incredibly diverse. The MFPA directory has 113 different products/ services listed that our members provide to each other and sell to consumers all over the world. Granted, the 113 listings are not all wood products, but it substantiates the tremendous breadth of our industry. So, if a company just makes pallets from purchased cut stock or has a trucking company that just hauls chips and dust should they really care about the huge decline in grade lumber demand? I would suggest that the answer is a resounding YES. I believe the most convincing argument to try and bring a diverse wood product industry together to support a sector that is particularly suffering is the potential impact on the forest. The forest, just like the industry, is really diverse and we must have markets for all the trees that grow there in order to support all the businesses that rely on a tree to stay in business. We must have a healthy industry to have a healthy forest, one cannot survive without the other. Market diversity allows us the opportunity to maximize the value of the tree to the landowner and maximizes the opportunity to apply forest management to the landscape.

Several years ago, MFPA played an integral role in defeating a mandatory "checkoff" that was being considered by USDA but was developed by a limited sector of the industry. Checkoff dollars, like those for beef, soybeans, corn etc are used to promote the industry that they are being collected from and develop new uses for the products. MFPA's board of directors supported defeating the checkoff effort because they felt the contribution calculation was not fairly distributed among the industry. Again, the diversity of the industry was a primary consideration in MFPA's decision to help defeat the checkoff.

Wood product PROMOTION seems to have universal support among our diverse industry, but the devil is always in the details. How, what, when, where, and why of promotion is a difficult question and everyone seems to have an opinion. My opinion, for example, is that there is no wrong way to promote our industry if we are delivering a message that supports real wood utilization and the businesses that make the products and provide the services to make it all happen. MFPA has been fortunate to receive a grant from Missouri taxpayers that will allow us to promote our industry and our products through many types of mediums and all that material will be available to whoever wants to use it to help promote real wood.

MFPA will be mailing out membership renewal packets next week and we hope that you all will consider renewing your membership for 2024. Enclosed in your packet you will see an opportunity to financially support the Real American Hardwood Coalition (RAHC). RAHC has voluntarily collected \$1 million in 2023 to promote real wood domestically and they are doing fantastic work with the Magnolia Network promoting our industry. PLEASE consider making a pledge to the RAHC and help them continue their work in 2024.


