

## **PROPOSITION A**

The Missouri Forest Products Association (MFPA) is a named plaintiff in a lawsuit filed to stop Proposition A from going into effect January 1, 2025 (minimum wage) and May 30, 2025 (sick leave). On Wednesday, December 11, 2024, the attorney representing the plaintiffs filed a motion to expedite the case with the Missouri Supreme Court. On Friday, December 13, 2024, the motion was denied by the court. THE MINIMUM WAGE COMPONENT OF PROPOSITION A WILL GO INTO EFFECT ON JANUARY 1, 2025. However, the lawsuit to challenge the sick leave portion of the proposition is still in effect and will likely be heard by the court in early 2025. The filed petition can be seen here if you would like to read the 18-page document.

Brian Brookshire has been interviewed by several news agencies regarding the Association's opposition to the proposition. We are using the following talking points to defend our position on opposing Proposition A:

- Proposition A is bad policy that will increase prices for consumers and harm businesses of all types and sizes, including Missouri's restaurants, grocery stores and small businesses.
- However, this legal challenge is focused on election irregularities and constitutional violations.
- The Missouri Constitution requires ballot initiatives to contain a single subject. Proposition A contains at least two clear, unrelated subjects minimum wage and earned sick leave.
- The Missouri Constitution requires the title of the ballot measure to clearly express its single subject. Proposition A's title is unclear and contains multiple subjects.
- The ballot measure's summary statement and fiscal note summary an estimate of the ballot measure's financial impact on state and local governments – are both misleading and insufficient.
- By exempting government entities and certain workers, Proposition A treats certain groups of people differently than others.
- This violates the 14th Amendment Equal Protection Clause.
- Because of this, Prop A must be overturned and ruled invalid.
- Our organizations receive questions every day from local business owners who are confused by components of Prop A that are either unclear or directly conflict with federal mandates.
- If the legal challenge is ultimately unsuccessful, the business community will seek legislative changes to Proposition A to ensure unemployment rates and cost of living are not adversely impacted by this proposition.

We will keep you posted on the status of the lawsuit as it makes its way through the legal system.
