

CALL TO ACTION FOR WOOD'S SAKE!

Members of MFPA have something in common, we all are involved, in one way or another, with wood PRODUCTS. We have loggers, sawmillers, manufacturers, insurance companies, equipment manufacturers, equipment dealers, trucking companies, truck dealers, foresters, landowners, among others. We all have a common interest, WOOD PRODUCTS, a renewable material that makes our lives better in many, many different ways. We have one more important bond, the TREE, we can't make wood stuff without them. Let's be honest, forests get managed, and trees get cut because they have economic value. Trees get purchased because there is a market for wood products and forests benefit when trees are properly harvested. It's a pretty simple formula that has worked for over a hundred years and our forests, wildlife, streams, and soil are better today because the "system" works, right? Well, it works until government subsidies are forced in the market with such pressure that they can alter decision making.

All members of MFPA need to be aware of the impacts of the Biden Administration's climate agenda and the potential harm that it can cause to our industry. In February 2021, I began making our membership aware of the potential impacts of President Biden's Executive Order "Tackling the Climate Crisis at Home and Abroad". At that time, many members of the industry had hope that wood products may actually be included as part of the solution to the harmful effects of atmospheric carbon. Scientifically, we all understood that wood products have the best environmental footprint compared to other man-made materials that are used for similar applications. Moreover, they come from trees that when managed properly, make up a forest that captures more atmospheric carbon as compared to those with no tree harvest. It's a win-win, right? Use wood products that store carbon indefinitely and manage forests to optimize their health and long-term sustainability and reduce the use of man-made carbon emitting alternatives. FOLKS, THIS STORY IS NOT BEING RECOGNIZED BY THE FEDERAL GOVERNMENT!!!

Wood products are not even being mentioned as a potential solution to the Biden Administration's climate crisis agenda. Regarding our industry in general, the "solution" is creating programs and agendas for public and private forest land to store atmospheric carbon in standing trees and selling that carbon in the marketplace. Please take time to view this video of Senator Josh Hawley asking Ms. Meryl Harrell, Deputy Under Secretary for Natural Resources and the Environment at USDA, about their recent actions regarding new management alternatives for "mature and old growth" forests specific to the Mark Twain National Forest. Also, read here the comments that MFPA helped prepare for the Federal Forest Resource Coalition to submit regarding this same issue. It is obvious during Ms. Harrell's testimony that there is potential for substantial change in how the Forest Service will manage mature forests that may impact our ability to harvest.

Last week, the Biden administration announced the "Investing in America agenda to help landowners access climate markets", a \$145 million government program. This agenda is focused on providing money to non-profits that will then develop outreach programs to landowners (many identified as "underserved") to help them enroll in and access carbon markets. The agenda can be read here. Not anywhere in the announced agenda is there mention of incentivizing wood products or encouraging forest harvest. I guess we will have to wait for the programs to be launched but I suspect this will be

a program focused on a per acre incentive for landowners to enroll their land in a management prescription (plan) that may, or may not, include the ability to cut trees.

On February 26, 2024 a lawsuit was filed against the Mark Twain National Forest challenging a NEPA decision that was conducted to initiate the "Forest Health Initiative Project". The lawsuit, which can be read here, is based on the opinion that the project NEPA did not conduct the proper carbon analysis and therefore the existing timber sales that have been prepared under the project should be stopped until the analysis can be completed. Currently the Forest Health Initiative Project includes 17 active timber sales totaling over 32 million board feet.

MFPA members, in my opinion, the hope that the Biden Administration's climate crisis agenda might include wood products and their known benefits to the environment, resulting in better and more sustainable markets for the industry, is NOT going to happen. In my opinion, what is happening at the federal level has the potential to harm our industry by reducing access to timber and competing with government incentives and carbon markets. Fact is, I have never seen mention of wood products as part of any solution to the "climate crisis" by this administration. I don't believe it fits their narrative to incentivize a product that comes from cutting trees. So, what do we do? Contact your federal Representative and Senators with this simple message:

I am a member of the Missouri Forest Products Association (MFPA) and I believe wood products should be a part of the "climate crisis" agenda. Wood products store carbon indefinitely and they come from a renewable resource, TREES, that naturally absorbs atmospheric carbon at optimal rates when they are healthy and vigorously growing. Trees cut at their natural maturity keeps forests healthy and sustainable and optimizes both atmospheric carbon adsorption and carbon storage in products. Please advocate for the wood products industry in Missouri, our ability to harvest trees, and include wood products in any incentive programs that are developed by the federal government. Missouri is home to a \$10 billion forest products industry, and we employ over 46,000 people and we should be a part of the climate crisis solution.

Don used to always tell me to BECOME a Master Logger should be easy...to STAY a Master Logger should be tough. The Missouri Master Logger Program was created as a result of the industry asking for a way to recognize loggers that go above and beyond the call of duty. Don was instrumental in bringing the program to Missouri. The program doesn't necessarily mean Master Loggers are better cutters, or better businessmen...just that they are willing to step up and have their work showcased and judged.

The Master Logger's 7 Areas of Responsibility include:

- 1) Protecting water quality and soil
- 2) Complying with government regulations
- Complying with acceptable forest management standards
- 4) Applying aesthetic management techniques where applicable
- 5) Following a preapproved management plan
- 6) Providing and participating in on-going training
- 7) Employing sound business management techniques

All that, and being judged by a higher standard. Every two years Master Loggers are subjected to a rigorous audit to ensure they are continuing to adhere to the rules.

Working with ANY Missouri Master Logger should give a landowner peace of mind knowing that the resource is being respected and well taken care of. Let's use Master Loggers when we get the chance.
