

#### 2023: WHAT TO EXPECT?

All the sudden, I was instantly happy. All the MFPA grandmas and grandpas know what I am talking about, it's a great thing. Nora is our first grandkid and I have quickly figured out that they are way better than our "firstborn" kids. Emily, Luke, Brett, Ben and Jessica, our children, all have caused their mother and I various stages of pain and discomfort and continue to do so. The dramatic downturn in the hardwood grade lumber market in the latter part of 2022, spanning the entire U.S. and impacting about all species, has certainly impacted most industries in Missouri. Googling this topic will reveal many "cause and effect" discussions but I think most grade lumber "crystal ballers" believe 2023 will continue to be a significant challenge. We pray for a rapid turnaround!

Finally, I am hoping, expect may be too strong of a word, that the Brookshire lab puppies, Geno and Bella, will turn a corner in 2023. They, like children who get speeding tickets, are also a major pain in the butt. Brett recently asked me "Dad, how can I repay you for taking care of Bella while I finish my senior of college?" I quickly responded, \$20,000 should do it to cover my pain and suffering and I will accept monthly payments. Don't see it happening.
